Fuel Consumption rate is fixed for Diesel 12 KM/Litter & Mobile 500 KM/Litter basis which is reimbursable as per existing rate on production of cash memo of fuel filling station..i.e. Vehicle owner will have to bear consumed fuel cost primarily & will pay said cost during bill payment from this office.
3. Marked Sealed Tender along with self attested copy of valid PAN Card, Road Tax Clearance, Rout Permit, Blue Book of car, Pollution Control Certificate, Insurance Coverage, Driving Licence of Driver must be reached in this office within 2.00 P.M of 29/01/2018. Besides this, incase of Firms self attested copy of valid Trade Licence, Prof. Tax Deposite challan, GST Registration, partnership Deed (if any) & EMD are also be enclosed alongwith Tender. 5. Haltage charge, Demurrage & Repairing cost of vehicle, accidental risk etc will not be broned by this corporation . For extra time work beyond 10 hrs. duty will be allowed to vehicle owner as per rate of the existing G.O. of Transport authority on monthly basis during bill payment.
