Sub: Notice seeking quotation for General Awareness Tableau.

This office issued a notice through this office No. 07/CA&FBP/MSD; Date: 27/06/2018 communicated vide Memo No. 473(10)/MSD/C&F; Date: 27/06/2018 seeking sealed quotations from the bona fide Ad-agencies etc for running of Tableau.

However, the notice is hereby cancelled as at least four numbers of valid quotations were not submitted on the due date, i.e. 05.07.2018.

Therefore, the same Quotations are again invited from the bona fide Ad-Agencies / Contractors / Suppliers for display of Tableau on TATA Ace or vehicle of same capacity for the purpose of awareness on 'Consumer Rights' and/or 'West Bengal Right to Public Services Act, 2013'.

The quoted rate must be inclusive of (i) Printing Charges of Banners etc., (ii) Fixing Charges, (iii) Vehicle Hiring charges including fuel and food for Driver, helper etc., (iv) Public Address System, (v) GST and other charges, if any.

Theme of the Tableau will be provided from the office to the Quotation-bidder whose Quotation will be entertained.

It must be noted that, in case, the quality of works done by the least quoted Quotation-bidder fails to satisfy the undersigned or other regulating agencies in any step or after one or more than one works, the quotation will be seek afresh by this office.

The Quotation-Bidders must submit copy of their (i) updated Trade-License, (ii) Photocopy of Valid PAN Card, (iii) GST registration certificate and (iv) at least one credential of Tableau running or Hoarding fixing and installation or Banner printing work at any Govt. Department or Govt. undertaking along with the Quotations.


Last date and time for submission of quotations: 26.07.2018 at 03:00 P.M.

The sealed envelopes must be superscripted with (i) "Quotation Notice No. 573(10)/C&F/MSD Date: 13/07/2018", (ii) Full name, address and contact no. of the Bidder. The Quotations will be valid up to Financial Year 2018-19 or total expenditure of ₹ 1, 00,000.00 whichever is earlier.

Submitted quotations will be opened on the same day, i.e. 26.07.2018 at 04:00 P.M. at the presence of the Quotation-bidders themselves or their authorized representatives. If, any of the quotation-bidder or his/their representative fail(s) to attend at the time of opening up of the quotation, he/they will not be able to raise any question regarding the process or accepted rate or other related matters.
