The consolidated pay or remuneration is payable to the employees re-employed on contractual basis should be debited from the detail head "02-Wages" under relevant head of Account of the Budget, as per order of Finance Department, Memo. No. 1662-F(Y) dated 24-02-2012. The Officer-in-Charge are requested to submit working certificate to the respective DDO's every month for payment of remuneration otherwise remuneration will be withheld.

Terms & Conditions

1. The Contractual engagement shall take effect from the date of joining and will continue for a period of 01 (one) year.
2. For the purpose of works mentioned above, this assignment will not be treated as employment / re-employment / commercial employment.
3. No other financial benefit other than consolidated contractual remuneration shall be admissible.
4. Retired employees (Cont.) will have the right to leave the contractual engagement after giving 15 days notice in writing. Similarly, this engagement is terminable, at the discretion of the authority, at any point of time, by giving 15 days notice in writing.
5. They may be transferred to anywhere in the district for the interest of public service.
6. Renewal of contractual agreement is subject to satisfactory & continuous service on receipt of certificate from the authority.
7. Prayer of renewal alongwith certificate of concerned authority must be submitted before one month of expiry. After expiry of contract or in absence of renewal remuneration will be stopped.
8. If the Retired employees (Cont.) agreed to accept the above terms & conditions, they are requested to indicate such acceptance in clear terms with date of joining on a duplicate copy of this letter, signed by him in full with date, within 07 (seven) days from the date of receipt of this order and send the same to the Genl. Estt. Section, Msd. Coll., falling which it will be presumed that he is not interested in joining the contractual engagement and this assignment would be offered to someone else.
