

1	Purpose	Adult Size body bags for disaster response human remains
2	Colour	Black
3	Dimensions	Length 88" X Width 36"
4	Thickness	250 GSM ( 5 ply)
5	Handling	Extra strong 3 carrying straps/handles suitable for handling by 2, 4 or 6 persons. Handles should pass static lift tested to 200 kg capacity.
6	Opening	Zipper: Easy access centre zipper opening with dual locking zipper pulls allowing bag to open from either end. Zipper made of high quality reinforced stainless steel.
7	Identification	Maintain identification and "Chain of Custody" integrity using serialized tamper resistant zipper pull seals, or disaster ID kit, etc.
8	Material	Made of Special lining High Density Polyethylene reinforced material of ISI: 7903:2017 quality. IS certificate of the fabric manufacturer to be provided. Impervious abrasion resistant exterior material. Impervious to blood, fats and other normal body fluids. 100% Leak Proof. Sealed on sides. Not biodegradable.

10	Shelf Life	Shelf Life in excess of 5 years.
