Resolution of the District Level Tender Committee, in reference of NIT No:CM/MSD/DH&FWS/1670(E) dated:28/02/19 and CM/MSD/DH&FWS/1670(B) dated:28/02/19 for Selection of Private Partner for establishment, operation and maintenance of 16 slice CT Scan and 5 bedded Dialysis unit respectively for Jangipur SDH/SSH, Murshidabad, held on 02.12.2019 at 12.30 P.M at CMOH Office, Murshidabad.

In reference of TO, SPSRC Department of Health and FWS, Swasthya Bhawan, Kolkata through e-mail for Review of Tender documents of M/s Eskag Sanjeevani Pvt.Ltd.

The following issue has been observed in the Tender documents, (Annexure-VII) submitted by the Eskag Sanjeevani.


1. In case of DR of Kalimpong District Hospital, Annexure VII edited from its original form and Eskag Sanjeevani has omitted row 7 in which bidders had to submit their total concession fees payable during the period (28 February 2019). and total concession fees actually paid for this (28 February 2019) period not mentioned. But Eskag Sanjeevani shows Row 11 that total payable to the hospital on date 0.00 but hospital authority payment received on 27.05.19 (Rs. 7,23,708) for digital X-Ray (date of commencement-13.02.2018) for 1st to 3rd qrs. But actual due date of payment was January,(vide a mail from TO,SPSRC) 2019.

As its clear mentioned in the draft document of tender which are uploaded by the TIA - For organization who are under PPP partnership (both O&M and EOM mode) with any government hospital under the DoHFW, Government of West Bengal, submission of documents related to clearance of dues, duly certified by the hospitals as detailed above is mandatory. The organization will be considered technically disqualified if relevant documents are not submitted.

The TIA has been found that M/s Eskag Sanjeevani pvt.Ltd. deliberately submitted the wrongly information and tampered documents which as per tender terms and condition is breach of trust and his candidature in the said tender may be cancelled and the decision of the Tender Committee is same that means the candidature of M/s Eskag Sanjeevani pvt.Ltd. is cancelled from NIT No: CM/MSD/DH&FWS/1670(E) dated:28/02/19 and CM/MSD/DH&FWS/1670(B). dated:28/02/19.

After cancellation of candidature of M/s Eskag Sanjeevani pvt.Ltd , only two bidders are technically qualified for NIT.NO- CM/MSD/DH&FWS/1670(B) dated:28/02/19. (vide memo no: CM-MSD/DH&FWS/5052 Dated: 02.07.2019.) So TIA has decided that the NIT .NO-CM/MSD/DH&FWS/1670(B) dated:28/02/19 is canceled.




Under these circumstances the Tender Selection Committee has recommended for the AOC to Mediview Diagnostic Service Pvt.Ltd.
